## **HAWTHORNE:**

### A QUIET NEIGHBORHOOD ON NORTH BRIARCLIFF

At last year's annual meeting, attendees were asked where they tell other Atlantans that they live. The responses in order of popularity were Northlake, I-85/Shallowford, Lakeside, and Other. We don't typically tell people we live in Hawthorne. Hawthorne is not recognizable as a community. Say Dunwoody, Virginia-



Highland or Tucker and immediately there is immediate recognition of geography along with a lifestyle perception.

There are pros and cons to being a secret gem. Maybe we don't want overwhelming hordes clamoring to live here, but an appropriate public image could help us attract the kind of people who will build the community we envision for our future. The pace of change is accelerating as many longtime local residents are now seek new lifestyles. If we wanted to be a little better known, how would we do that? We could start with all of us identifying our home community in the same way. We could say "Hawthorne" and try to establish that name or maybe there's an easier way.

Briarcliff Road is a main artery running through our neighborhood. While Briarcliff may not be as identifiable outside of Atlanta as Peachtree Street is, most Atlantans know Briarcliff Road and the name conjures up positive images in most peoples minds, either of big old houses or a traditional two-lane road running through wooded countryside. It's a long road, touching a number of well-known and popular neighborhoods such as Druid Hills, Virginia-Highland, Morningside and Emory. Look at Briarcliff on a map. Between Shallowford and Cravey, Briarcliff is at its most northerly. From there, Briarcliff heads southwest toward Oak Grove and southeast toward Northlake. The next time somebody asks you where you live,

try saying "North Briarcliff" and note the response. Collect those reactions for discussion at Annual Meeting.

#### HAWTHORNE ELEMENTARY

Last spring, the Hawthorne PTA hosted an introduction to Hawthorne Elementary for local realtors. The following is a capsule of what they heard.

Being a small school of approximately 300 students, Hawthorne teachers and staff are able to provide individual support and recognition to each child. Additionally, a special partnership with Coralwood Elementary allows Hawthorne additional personnel which equates to almost two teachers in every classroom for language arts and math instruction. As research supports, lowering the teacher pupil ratio is a key component of student success which is most evident in Hawthorne's recent test scores.

During the fall of 2004, DeKalb County administered the lowa Test of Basic Skills to all students in grades 1-5. The lowa Test of Basic Skills is an achievement test that provides individual schools with information about how their students perform in relation to other schools across the nation. Schools scoring at the 50<sup>th</sup> percentile are average. Hawthorne students scored well above the average national score. Furthermore, scores indicate that Hawthorne students are scoring similar to our nearest school neighbors in

grades 3 and 5 (State Department required grades for testing).

#### PDK MASTER PLAN: PUBLIC PARTICIPATION SIDETRACKED

**BACKGROUND.** Master Plans are important documents that guide, direct, and set limits on project development. **The DeKalb Peachtree Airport (PDK) Master Plan process that is currently underway will guide and set limits on PDK Airport development for <u>the next several decades</u>. In August 2004, the DeKalb Board of Commissioners authorized the development of a new PDK Master Plan, utilizing professional consultants and promising extensive public involvement throughout the entire process.** 

Six months and \$80,000 into the project, the consultants had produced two strong reports by April 2005 -- the first on Public Involvement in the process and the second a 6-page PDK Vision & Policy Document. This second report identified seven key vision and policy themes: (1) safe and efficient operations, (2) environmental sensitivity, (3) community relations, (4) financial self-sufficiency, (5) general aviation, (6) customer friendliness and (7) effective institutional framework. Full details are available at www.pdkwatch.org. The consultants intended their vision and policy document, along with the public involvement plan, to be used "as a means to provide structure to the master plan development process" after its review and adoption by the PDK Airport Advisory Board (AAB) and the DeKalb Board of Commissioners.

**RECENT ACTION.** At the three AAB meetings in April, May, and June 2005, the consultants' policy report and all-but-one of the nine proposals from the public were <u>blocked from even being discussed</u>. Instead, Richard Ossoff, chair of the AAB, put forward his own one-page set of loosely-drawn policy proposals that appear to leave the airport largely free to develop as it chooses in the future. These policy proposals, with minor modifications, were approved by the AAB in June 2005, and are being recommended to the Commissioners for adoption.

#### **CONCERNS**

- It would be hard to disagree with the general sentiments expressed in the AAB policies but the policies fail to provide clear and explicit <u>limitations</u> on PDK expansion. Missing are (1) an explicit reaffirmation that PDK will remain a <u>general aviation airport</u> and undertake no engineering measures that could allow it to become a Class III airport, capable of accommodating much larger jets and (2) the 1992 Master Plan <u>prohibition on airport physical expansion</u> beyond its current boundaries (except under certain specific circumstances). Why were the excellent recommendations from the professional consultants set aside? Why is the AAB unwilling even to DISCUSS more than the limited range of policy proposals put forward by one of its own members?
- At a BOC work session, August 2, airport director Remmel and AAB chair Ossoff are scheduled to
  present the AAB recommendations. There is no provision for public comment at work sessions;
  no public comments, questions or rebuttals. How will the commissioners get a full perspective on
  the issues?

#### WHAT CAN A CITIZEN DO?

- 1. **Get more detailed information** about the PDK Master Plan process and how its public participation component appears to have been derailed by the recent actions of the PDK Airport Advisory Board at **www.pdkwatch.org** in the Master Plan section.
- 2. Contact your County Commissioners about your concerns and encourage them to consider seriously the recommendations of their <u>own</u> Master Plan consultants and the public before adopting policy guidelines for the PDK Master Plan. In particular, ask the Commissioners to approve a clear policy preventing PDK Airport from changing from its present Class II "general aviation" status into a Class III airport that would allow larger and more disruptive jets.

#### **GREENSPACE UPDATES**

A contractor (IPC) was scheduled to continue invasive control work in **Mary Scott Nature Preserve** in early to mid July, attacking most of the remaining invasives including English ivy. Some sensitive areas may be done in the fall. In late May, construction documents were being prepared but the project had not gone out for bids.

Greenspace Steward Training is being offered to the public by DeKalb Parks & Recreation. This FREE training is an introduction to greenspace ecology, invasive plant control, and stream protection. Held at Forty Oaks Nature Preserve, 3790 Market Street in Clarkston, the 9am to 1 pm training will be repeated on different dates:

#### **UPDATE: PDK OPEN RECORDS LAWSUIT**

Major progress has been made recently in the PDK Open Records Lawsuit (Feltus v. DeKalb). It seeks to gain the full release of the Countyheld records on PDK flight operations to which the public is entitled under the Georgia Open Records Act. Release of those records is essential if the public is to be able to take the crucial additional steps that are necessary: (1) to put a stop to the illegal use of PDK Airport by the estimated 1,000+ oversized, noisy jets that annually exceed the County's 66,000 lb. PDK weight limit, and (2) to insure that the roughly half of the all aircraft based at PDK that are not paying their required County taxes- estimated to exceed \$4 million annually--do so.

On June 2, 2005, the lead counsel for the Open Records Lawsuit. Brandon Hornsby, made a compelling presentation of the case for a summary judgment requiring DeKalb County to open the PDK flight records it has been withholding from the public. We expect a favorable decision by the end of the summer. In the meantime, if the case is to be able to

continue in order to secure PERMANENT, INJUNCTIVE RELIEF from use by noisy, oversized jets, your generous, continuing financial support is ESSENTIAL. How much are your property values, quality of life, and ties to this neighborhood worth to you?

#### **PET PEEVES**



- Owners not picking up after their dogs <i illegal >. You wouldn't expect your neighbor to take care of your baby's diapers; don't expect them to take care of your dog's droppings.
- **Dogs and cats off-leash** <<u>illegal</u>>. Your dog could be affectionate with you and aggressive toward others, or it could encounter a not-so-friendly animal or vehicle.
- Loose pets without a tag with a current phone number. Tags should be current and legible. If you can't deal with a lost pet in your vicinity, try contacting a nearby dog-owner. If there's no one closeby, Brad & Jill (Hawthorne Place, 678/592-6129), Chantal (Sherbrooke Drive, 404/633-5031), Beatrice & Gary (Sherbrooke Drive, 404/728-9788), Debra (Shasta Way, 404/321-0006) and Carolyn (Flair Knoll Drive, 404/982-9881) are willing to try to help. #### Pet hazard reminders:

- ✓ Pet food left outdoors attracts wild animals. Try not to attract coyotes or rabid raccoons.
- ✓ At 85°, the dashboard temperature of a closed car can reach 170° in less than 15 minutes.
- ✓ Dogs' feet can burn touching asphalt on a hot day, especially if owners stop to talk.

#### NORTHLAKE COMMUNITY ALLIANCE

(NCA) held it annual membership meeting June 2 at Northlake Mall. Two open business representative seats were filled. As described by NCA's consultants, several things have caused a one year delay in the initiation of construction of the Phase I LaVista Rd. Streetscape project. First, a need to modify an intersection project where Briarcliff meets LaVista (rt. fork of the triangle at Northlake) which will require a minor modification of the plans and the studies (Right-of-way acquisition, environmental and historic pres.) for the corridor, Additionally, GDOT has not agreed to the joint use lanes intended for bicyclists in each direction. AND GDOT's area sidewalk plans for 2008 (LaVista from Nlake Pkwy to Harobi Dr.) have been merged with the streetscape project, to be done in 2007. This allows for economies of scale and probably a much better project in the end.

#### SAFETY / NEIGHBORHOOD WATCH

HCA continues to work with the DeKalb police to try to set up a communication system that is not dependent on having a traditional neighborhood watch (70% participation/signatures). The following incidents have been reported to Hawthorne Civic Assn:

- A second check (different victim) has been "washed" and presented at a local bank with altered payee and altered amount. Always take checks to a secure mailbox, the closest being within the UPS Store.
- June 10, around midnight, a coyote was spotted on Flair Knoll Drive at the top of the hill. TV
  news reports say that small dogs and cats can be at risk.
- June 11, before sunrise, Brookdale / Hawthorne Drive area: Stranger sitting in neighbor's truck in neighbor's carport. Later, the door of a car in another driveway was found ajar; a CD player and CDs missing.
- A reliable source reports an attack on a woman during her 9 am walk in the Briarcliff Woods area. She thought he was on a morning walk like herself, until he ran up from behind and put her into a choke hold. Her screams scared him off, but he did stop and smile at her as he fled.

#### **ZONING / DEVELOPMENT**

The SLUP application from Light International Ministries for transitional housing of 100 children with problems in the **Tara Trail** Apartments was DENIED by the DeKalb County Commissioners on 4/28/05. Thanks to HCA members, HCA zoning chair Betty Phillips, residents of Peachwood Circle and members of Dresden East Civic Association for their efforts.

A proposal to modify the zoning of **Shallowford Lodge** (other side of I-85) to C1 to allow the use of the first floor for retail shops was DEFERRED for a full cycle by the Board of Commissioners (6/30/05) despite Denial by the Planning Commission and opposition from the community. HCA and DECA will continue to oppose this application.

**SIDEWALKS.** Briarcliff Road from Northlake Mall to North Druid Hills Road has been surveyed for a proposed GDOT and DeKalb County joint sidewalk venture. {from *The Story*, 6/16/05}

**IN-FILL.** Within the HCA area, especially around Echo Lake, the pace of change has increased dramatically. New houses catch your eye on Circlewood, Raintree, Melinda and Melinda Court with pricetags between \$729K and \$869K. To some, our neighborhood's existing houses are sensible, simple-life bargains. To others, existing houses just hide the dirt on which a dreamhouse can be built. Is there a way to provide what some people want without destroying what other people want/have? Everyone has the right to swing their arm as long as it doesn't hit anyone else. The DeKalb InFill Task Force (www.dekalbinfill.org) is charged with designing new zoning code to protect everyone; Commissioners may vote by late summer. One proposal: benchmark measurements taken prior to demolition that guide the replacement's design. The HCA board would like your input on what's fair and what we should stand for; send your thoughts to HCA@gazebosoftware.com or talk directly to a board member. We recently received a letter from a Nancy Lane resident in disbelief about the demolition of the home of old friends which had been in good shape when it sold: "It had a new roof, was lovely inside and out, and had a new driveway."
