ZONING & DEVELOPMENT

- On September 23, 2008, the DeKalb County Board of Commissioners acted to defer decisions on three large developments in our district (Commission District 2):
 - 1) A 68.26 acre mixed use development called "The Park Druid Hills" at North Druid Hills and I-85, for which details had not been completed.
 - 2) A 37.14 acre proposal to redevelop the Williamsburg Apartments site at North Druid Hills and Clairmont Road, under a "Town Center" land use designation. A land use map mix-up has created the need for clarification and evaluation of the facts. Opposition is very strong against the density and heights that could be possible as a Town Center.
 - 3) A 22.54 acre development which fronts 796 feet on Buford Highway and 1041 feet on Curtis Drive for a Comprehensive Land Use Plan change to Town Center designation. The deferral was to consider a design plan for the area as a whole including Northeast Plaza.
- A fourth application for "Town Center" designation was withdrawn from the agenda. This currently residential 8.93 acres with 1428 feet frontage on North Druid Hills abuts the Merry Hills neighborhood at the rear.
- New on the agenda was an application by the DeKalb County Board of Commissioners (Commissioner Jeff Rader – District 2) to enact an amendment to Chapter 27 of the Code of DeKalb County allowing nightclubs as a Special Land Use Permit in the districts specified, to define late night establishments, and to authorize use in the following districts, O-I, O-D, NS, OCR,C-1, C-2, M, PC-1, PC-2, PC-3 and the I-20 Overlay District pursuant to a special land use permit and to enact supplemental regulations. The DeKalb County Zoning Ordinance does not currently provide for the location of nightclubs in any zoning district other than one of the tiers of the I-20 Corridor Overlay District. The Code does not currently provide comprehensive land use regulation of nightclubs within the County and the effect of the emergence of such establishments on the County's quality of life.

The process of obtaining a Special Land Use Permit (SLUP) includes a public hearing where the public can comment. Commissioners can approve, deny or attach conditions that limit activity on the site for each application. The Commissioners voted to defer their decision to the meeting on October 14.

At the August 12, 2008, County Commission meeting, a contract for development of Mary Scott Nature Preserve was approved. We had no advance knowledge that this request would be coming from the Parks Department. We have yet to see a copy of the contract but the BOC Agenda item read as follows:

MARY SCOTT NATURE PRESERVE PARK DEVELOPMENT:


INVITATION NO. 08-100086 for use by Park and Recreation Department;

Mary Scott Nature Preserve Park Development will create a user friendly public accessible park. To include the following: 7' wide mulch trails, entry signage, custom cedar benches, picnic tables, trash receptacles. Also included are: all appropriate erosion control measures, strategic clearing of undergrowth, and removal of hazardous dead trees that pose a public danger. Nine (9) bids received. Recommend award to low bidder meeting specifications: Ed Castro Landscape, Inc.; 1125 Old Ellis Road; Roswell, Georgia 30076. Edward Castro, President. NOT TO EXCEED: \$273,341.18

DROUGHT / WATER USAGE



At the time of editing this newsletter, we are still under Level 4 Drought Restrictions.

http://www.dekalbwatershed.com/water_restrictions2.html keeps up-to-date on what the **watering restrictions** are. There are exemptions for re-use of previously used water (gray water), for new plantings and a few other less common things, but generally each household, business, institution, or property owner is allowed to use one garden hose, 25 minutes per day, during designated days to water plants only -- existing lawns are not included. The hose must be hand held during watering and equipped with a standard spray nozzle that automatically turns off when you let go of it. Even-numbered addresses may water on Mondays, Wednesdays, and Saturdays between the hours of 12:00 midnight and 10:00 a.m. Odd-numbered addresses may water on Tuesdays, Thursdays, and Sundays between the hours of 12:00 midnight and 10:00 a.m.

Commissioner Rader sent a reminder, Sept 11, that residents in DeKalb County may apply for a rebate to help with the purchase of **water-efficient toilets** to replace older models. The rebate is available until the county exhausts the funds set aside for this rebate program. The program, approved by the Board of Commissioners in January 2008, offers \$100 rebate for the purchase of toilets that use 1.28 gallons per flush and a \$50 rebate for toilets using 1.6 gallons per flush. The rebate is good only for those homes built prior to 1993 and up to a maximum of three toilets in such households. Only brand names and model numbers pre-approved by DeKalb are eligible for the rebate. As of late August, the county has disbursed a little more than half of the \$500,000 set aside for the toilet rebate program. Homeowners have replaced more than 3,500 toilets with this rebate program. That translates to an estimated annual savings of 46 million gallons of water in the county. PROPOSED CONSTITUTIONAL AMENDMENTS:

- 1- TO ENCOURAGE THE PRESERVATION OF GEORGIA'S FORESTS THROUGH A CONSERVATION USE PROPERTY TAX REDUCTION PROGRAM. "Shall the Constitution of Georgia be amended so as to provide that the General Assembly by general law shall encourage the preservation, conservation, and protection of the state's forest through the special assessment and taxation of certain forest lands and assistance grants to local government?"
- 2- TO AUTHORIZE LOCAL SCHOOL DISTRICTS TO USE TAX FUNDS FOR COMMUNITY REDEVELOPMENT PURPOSES. "Shall the constitution of Georgia be amended so as to authorize community redevelopment and authorize counties, municipalities, and local boards of education to use tax funds for redevelopment purposes and programs?"
- 3- TO AUTHORIZE THE CREATION OF SPECIAL INFRASTRUCTURE DEVELOPMENT DISTRICTS PROVIDING INFRASTRUCTURE TO UNDERSERVED AREAS. Shall the Constitution of Georgia be amended so as to authorize the General Assembly to provide by general law for the creation and comprehensive regulation of infrastructure development districts for the provision of infrastructure as authorized by local governments?

DEKALB COUNTY REFERENDUM. Shall the Act be approved which provides for the presiding officer to preside over meetings of the DeKalb county Commission and for the commission to establish its own agenda for such meetings?

DEKALB COUNTY BOARD OF EDUCATION NONBINDING ADVISORY REFERENDUM. Should the DeKalb County Board of Education require that students in kindergarten through fifth grades wear school uniforms?



Monday, October 20 ... CANDIDATES FAIR 7-9 pm, Greek Orthodox Cathedral on Clairmont Road.

As has become our custom, NBCA is joining with other local civic associations, under the banner of the Civic Association Network (CAN), to host a Candidates Fair. Candidates/campaigns are invited to set up "booths" where voters can talk to them (whichever candidates you want to know more about) and pick up their literature. This time, candidate presentations will also be scheduled in a subsection of the venue. The intent this fall is to focus on races with opposition, but unopposed candidates who would like to attend will be welcome.



DECISIONS & PLANNING

- The DeKalb County School System has requested bids by 9/30 for the design of a **new K-12 performing arts complex** to be located on the 31.7 acre North Druid Hills property which would also be able to be used by the community and rented out for income. Current estimated construction costs of \$87 million would be raised as a separate project and not from the current construction program.
- The County Commission approved funding provisions enabling the process to begin to look for **librarians and support staff** to operate the Barbara Loar library (Northlake) and the Avis Williams Library (Toco Hills) scheduled to open in 2009.
- The County Commission postponed until November 4 a decision about whether to file a **lawsuit challenging the incorporation of the City of Dunwoody**. Commissioner Lee May contends that voters throughout DeKalb County should have had a vote on the incorporation and that their voting rights were not protected. It is expected that the county could lose millions of dollars in revenue due to the incorporation.
- TABASCO (Transform and Beautify Along Shallowford Corridor) continues to work toward developing a **vision of the county-designated "Neighborhood Center" (Shallowford @ I-85) and all along Shallowford Road**. NEIGHBORHOOD WATCH / SAFETY

NBCA has heard little to nothing about incidents in our community lately, though we have been hearing about incidents in other neighborhoods and at shopping centers. Merchants in the Northlake area have come together at least once to talk about it. While there have clearly been a good number of smash-and-grab incidents, conflicting e-mails about the number of people accosted in parking lots have been flying. This kind of incident typically becomes more prevalent during the holiday season.

- Always be aware of your surroundings and park in well-lit areas in view of as many people as possible.
- Never leave unattended valuables visible in your parked car or in your shopping cart.

AUTOMOBILE BREAK-INS AND THEFTS

For most folks, their home is their most valuable investment and their automobiles are one of their most valuable possessions. Are you doing all that you can to protect your assets? Every area experiences incidents of unlocked autos being broken into or stolen from garages, driveways and the street. Many areas in our District 2 community are seeing an increase in this activity. Let's all do what we can to make sure our area less desirable for those who commit crimes of opportunity. Protect your loved ones and your possessions by following these suggestions:

1. **ALWAYS LOCK YOUR VEHICLE!** Whether it's in your carport, in your closed garage, in front of your home or parked on the street, you are inviting theft and loss by not locking your vehicle. Teens and vagrants look for easy targets, and your open car doors promise easy access to radios, CD players, GPS systems, change, and other personal contents. Someone can also enter your car and accost you while you're driving. Why make it easy for them to victimize you? Thieves are at work in even the nicest neighborhoods all the time. Take precautions.
2. **ALWAYS KEEP YOUR GARAGE DOORS CLOSED!** It may be inconvenient or hard to get used to, but you give strangers better access to your home, your car and your property contents if you don't keep your garage doors closed. Why invite a thief into your personal space by making yourself a target? Can you really afford to lose the contents of your garage or your vehicle because you forgot to keep the doors closed? And keep the lights on at night if you're going in and out of your garage. Lights discourage criminal activity.
3. **ALWAYS USE YOUR ENUNCIATOR.** If you have a home security system, leave the enunciator on at all times. (That's the chime that rings every time a door or window is opened or closed.) If you won't keep your garage doors closed, or your home's entry doors locked, at least allow your security system's audible signal to operate. It might warn you of unauthorized entries into your home before it's too late.
4. **NEVER LEAVE VALUABLE ITEMS IN YOUR CAR, LOCKED OR UNLOCKED, FOR EVEN A FEW MINUTES.** If you don't get around to removing personal items from your car, someone else will, even if your doors are locked. Store items in a locked trunk, or take them into the house. Yes, it takes a few more minutes and requires some effort, but that time is well spent compared to losing your car, your property and your peace of mind. If you leave temptation on display, you're part of the problem, not the solution.
5. **ALWAYS REPORT ANY INCIDENTS TO THE DEKALB POLICE DEPARTMENT AT 404-294-2911.**
6. **ALWAYS TALK TO YOUR NEIGHBORS.** You have an obligation to stay current on developments in your community. Information is available to you from a number of sources, including the NBCA's website, www.northbriarcliff.org. If you see suspicious folks or vehicles in your area, report them immediately to the police.

COPPER THEFTS (with thanks to the Civic Association Network and Beth Bond for this timely information.)

Copper thefts are increasing in metro Atlanta as the price of this valuable metal skyrockets. Thieves steal copper from homes, offices and catalytic converters on vehicles. The criminals that steal copper are experienced and operate quickly. What can you do to protect your home and property?

1. **IDENTIFY YOUR SOURCES OF COPPER.** Copper can be stolen from air conditioning units, plumbing, crawl spaces with exposed copper piping and vacant homes (where interior walls are cut open for removal of pipes.) Catalytic converters can be cut from under most vehicles.
2. **PROTECT YOURSELF FROM COPPER THEFT.**
 - a. Secure crawl spaces by ensuring you have a sound and sturdy door frame door with a good lock. A case-hardened padlock or deadbolt lock is a good choice. So is enclosing entry areas with locking bars.
 - b. Mark copper pipes with a unique color or initials for identification purposes.
 - c. Enclose air conditioning units with a custom cage.
 - d. Vehicles with catalytic converters should be parked inside a locked garage.
 - e. Call 911 to report suspicious persons and vehicles, then share these descriptions with your neighbors.
 - f. If you are a victim, consult a reputable licensed plumber and inquire about alternative replacement options.
